

November School Council Meeting Minutes

Monday, November 15, 2021 6:00 – 7:00pm School Canteen

- 1. **Meeting called to order** at 6:02pm followed by Opening Prayer led by Devon.
- 2. Land Acknowledgement
- 3. **Approval of Minutes** No previous minutes
- 4. **Introduction of Chairperson & Report** Laurie Catonio was introduced as the new Chairperson. She provided an introduction to herself and experience in this role. The SFJH School Council Mission Statement is old and needs to be reviewed. Council may want to consider reviewing Council Bylaws as it is about 20 years old.

ACTION ITEM: Members to review Mission Statement at next meeting. Council bylaws attached.

"As a School Council, we support the Mission Statement of St. Francis Junior High School which states that we are a Catholic Faith community dedicated to educating and fostering the growth of responsible citizens who are life long learners encouraged to live and celebrate our faith".

- 5. **Treasurer Report** No report. Devon stated Council has about \$3500.00 left from the beginning of the year but should have some school fee deposits. Uncertain of other expenses beyond awards money already paid out.
- 6. **Introduction of New Trustee & Report Divisional News** Bob Spitzig is the new SFJH School Liaison from the Board of Trustees. After the recent municipal election, there are 3 returning Board Members and 7 new members. The board has met and had a conference already with a lot of information being presented.

Bob commented that the Board is aware of the ongoing bussing issues and working with Southland Transportation to help solve them. There are a lot of new requirements bus drivers must meet and so there is a shortage. Insurance premiums have also increased and the Board is trying to be compensated by the government for those significant increases.

Discussion of school door times followed due to busses arriving early. Doors of the school will be opened at 7:30 am for bus students who are arriving early to the school. Administrators/Teachers will be there to supervise. Staff are expected to be to school 15 mins before and 15 mins after so administrators will cover gaps. The Complex Needs bus is arriving 30-60 minutes late each day. School is aware of this and working to help correct this.

7. Principal Report - SFJH News (Devon Dempsey/Darren Miller)

- a) **Meeting Dates**: November 15, December 13, January 17, February 14, March 21, April 11, May 16, June 20 Council agreed to not have a meeting on Feb 14. Meeting dates need to go on the website
- b) Faith Plan Darren provided a Faith Plan update (see attached powerpoint). Staff are being supported to journey together in faith.
- c) Athletics Update Darren reported that cross country went well but no trip to Medicine Hat due to being asked not to travel. Two students won Cities. Volleyball finished last week with Jr Girls getting a Silver in Cities, Sr Girls getting a Silver in Cities as well. Basketball started this week.

There is a noticeable lack of development of athletes due to COVID so great to see kids participating again.

Shout out to all the coaches who make athletics possible. Live stream was a great bonus for parents/family/friends. No parents in the stands did help athletes to focus. Spectators for basketball to be determined November 16th in meeting with other schools.

- d) Musical Update cast has been posted and rehearsals are in full swing
- e) Interventions Update LLI & WIN Literacy and Numeracy Interventions are paying off. SFJH is the first Junior High in the division to move to a fully inclusive model. There has been noticeable need for reading/numeracy interventions after COVID. Every student will have intervention/enrichment time. Grade 7 started first during Literacy time. Grade 8 and 9 have WIN time.

A member with a child with exceptionalities commented that they were concerned about full inclusion but are loving it for their child.
